When can I expect to get my point of connection?

- For developments up to 500 dwellings we expect to reply within 14 calendar days
- For developments larger than 500 dwellings or where there is a requirement for non-domestic water (e.g. for factories or industrial use), we may need to carry out investigation work, if this happens we will contact you within 14 calendar days of your application with a firm date when your reply will be ready
- We will always contact you within 5 calendar days of receiving your application to confirm we have all the information we need or to ask you for any additional information that we may need

Charges

We don't make an application charge for providing a point of connection if the site will use water for domestic purposes only.

If your site will use water for non-domestic purposes (e.g. a factory or industrial process), we will confirm our application charge 3 working days after receipt of your application. You will need to make this payment before the point of connection can be provided to you.
