Thank you for your request for environmental information. We appreciate your interest, and we want to let you know that as United Utilities (UUW) are not subject to the Freedom of Information Act, your request has been carefully considered in accordance with the Environmental Information Regulations (EIR).

## Your request:

I have been in communication with the Environment Agency regarding the legal requirement for businesses to refrain from disposing of milk down any drain (regardless of where the drain goes).

They advised that it was down to the water companies to consent to this. I was surprised to hear this as it's either illegal or it isn't, but I'm getting touch as United Utilities are the water company for the business in question (a client of ours in Preston). Please let me know what is allowed.

In addition to the above, please can I make a Freedom of Information request for all businesses that have a permit with United Utilities for discharging milk to drains.

Please also provide what is allowed by United Utilities for businesses pouring milk down drains and if allowed, why this is, as it seems to be in direct contravention to the regulations.

## Our response:

It is the position of UUW that raw and waste milk must not be discharged to the foul sewer. Milk has a high biological oxygen demand (BOD) and can significantly impact the biological treatment process at our Wastewater treatment works and negatively impact the receiving watercourse.

The Animal By-Products Regulations (ABPR) impose strict controls on the disposal of waste milk, with the rules dependent on if the milk originated from a farm, processing plant or retail premises. ABPR details methods of disposal dependent on point of origin including use as animal feed, spreading to land or transfer to an approved facility for disposal. We maintain that raw and waste milk should be properly disposed of in accordance with section 34 of the UK Environmental Protection Act 1990.

We do however consent dairies and bottling plants to dispose of wash water from milk production which is controlled as trade effluent. Companies proposing to undertake these activities must first apply for a trade effluent consent with our Trade Effluent Team. The trade effluent consent will include a list of matters which should either be limited or eliminated prior to any trade effluent discharge, in addition to the maximum temperature and pH parameters.
