## Irwell Catchment Partnership Letter of Support for United Utilities Green Recovery Proposals

As CaBA Catchment Host and on behalf of the Irwell Catchment Partnership CaBA Group, which has a particular focus on the protection and enhancement of the environment and communities, I am keen to lead engagement through the Partnership to develop new initiatives that help to deliver objectives aligned to the Irwell Catchment Plan.

Having been involved in the development of the proposals that United Utilities would look to deliver I am are pleased to note that these support the ambitions of the Irwell Catchment Plan and that a partnership approach has been taken in identifying what can be achieved and how best it can be delivered. The Irwell Catchment Partnership, through Defra's Catchment Based Approach (CaBA), provides a unique opportunity for coordination of a consortium of partners to co-design, co-fund and co-deliver improvement measures on the ground. The complexities of the River Irwell Catchment require partners to collaborate in order to achieve real change; partners appreciate that 'business as usual' approaches will not tackle the failures identified or achieve the standards required – we need to find ways of working that are effective, complementary, offer value for money and maximise the local context.
